Biographical Sketch

Clara Beckley, a librarian, genealogist, and historian, was a native of New York. Born on 5 January 1880, Clara's main research concern was the genealogy of her family and the development of her grandfather's iron foundries in New England. John Adam Beckley (2 September 1808 - 14 June 1874) was pivotal to the expansion of the early New England iron industry. He brought his expertise to East Canaan, Connecticut, where he opened a furnace in 1837.

An ancestor of John Adam Beckley, Richard Beckley, was an iron producer in Sussex, England before coming to New England circa 1635. Arriving first in New Haven, Connecticut, Richard Beckely later purchased land near Wethersfield, Connecticut from the Mata-bee-set Indians. The area is now known as Beckley Quarter.

John Adam Beckley built, owned, leased, and operated several charcoal pigiron furnaces in Harlem Valley, New York; Massachusetts; Connecticut; and Vermont. Working with his son, James Beckley (14 October 1839 - 10 March 1888), and grandson, Samuel Groat Beckley (11 April 1863 - ca. 1928), John became an award-winning manufacturer. In 1866 the American Institute at New York awarded John Beckley a gold medal for, according to Clara Beckley, "making the best iron in this country and, in fact, the best iron in the world." During the Civil War the forge in North Adams, Massachusetts produced iron that plated the U.S.S. Monitor

After the death of John Adam Beckley, James Beckley and Samuel Groat Beckley continued running the family businesses. James was married to Adeline Groat. Their children included Samuel Groat (d. 1928), Lizzie Monson (31 January 1865 - ca. 1932), and Clara.

Scope and Content

This collection has been divided into two series: the genealogical research of Clara Beckley (Box 1) and the primary sources she gathered related to her family's iron foundries (Box 2). Within each box, folders have been arranged alphabetically according to the type of document and main focus of the material. Within each folder the documents are arranged chronologically. If the date of production could not be ascertained, the documents were then placed in the back of the folder.

Series I: Clara Beckley genealogical research This series houses the personal papers and genealogical research material of Clara Beckley. The majority of the documents were written by Beckley between 1940 and 1958. Personal correspondence, from 1940 to 1957, details Clara's research requests and her effort to make the extant Beckley family furnaces permanent historical monuments. Photographs in the collection focus primarily on Beckley homes and businesses, as well as Clara herself. One folder is devoted to he Beckley's involvement with the original construction of the Civil War era U.S.S. Monitor.

Series II: Business transactions Documents related to the day-to-day business transactions of the Beckley furnaces may be found in Series II. Much of the material was sent to and from John Adam Beckely between 1876 and 1888. Additionally, the collection contains memoranda (1880s), Supreme Court documents (1876-1890), bills of sale (1866-1884), and original building plans for the S. Boston Iron Co. in Dover, Massachusetts (1881). Personal items of John Adam Beckley include medicinal recipes, fractional currency, and a notebook.
