5. Publication is permitted only from images directly supplied by the CHS. Images produced by the user are for research purposes only and are not for publication.
6. Each image must be reproduced in its entirety and without any alteration, including cropping, bleeding off the page, overlapping, overprinting, or change in color, unless otherwise approved in advance by the CHS. Any altered or detailed image must be labeled as "altered" or "detail."
7. The complete credit line as supplied by the CHS must appear in the caption or list of credits for each reproduction.
8. Rights to reproduce are non-exclusive and are granted for the one-time use or uses only, as detailed on the application form. Any further revision, editions, reprinting, e-books, or additional use requires a new application to be submitted and fee to be paid.
9. Permission is valid only for the individual, company, or institution to whom it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of without written permission of the CHS.
